 - b. Being a person of upright moral standing
 - c. Involvement in church groups
 - d. Active use of his/her time, talents and resources for the mission of the Church
 - e. Conducting School Worship
- 8. This form is a record of commitment to the PCTT.
- 9. The applicant will receive a verification email within 24 hours of delivery to the office.
- **10.** The term Board/s connotes any higher arm/court where Eldership is required.
- 11. Co-opted members' voluntary service to Boards is considered service to the PCTT.
- **12.** A copy of the Baptism & Confirmation Certificate must be attached to provide reference.
- **13.** All information provided will be treated with utmost confidentiality.
- 14. The Period of this report will be for two (2) years.
- 15. The applicant must be an active communicant member for a minimum of two years.
- 16. All signatures affixed, indicates that the information contained on the form is reported accurately, and that all parties involved are in agreement with its contents.
